City Wide Street Milling & Resurfacing FY 2017 (Renewal)

Please be advised that the City of St. Petersburg has recently authorized a contractor to perform resurfacing of the street abutting your property.

The resurfacing work will consist of a hot-mix asphalt concrete overlay on the street. A door hanger notice will be distributed two to four days in advance of the work, indicating the date of street resurfacing. Please do not park cars on the street or water lawns on the day of resurfacing.

The project cost for this City wide street resurfacing project renewal for Fiscal Year FY17 is \$4,085,000.00. Funding is made available from the City's share of the Penny for Pinellas one percent (1%) sales tax. Completion of this project is anticipated to be June 2017.

The City will have a full time construction inspector available to answer questions or address concerns in the field. Feel free to contact Mr. Dusty Kersey, Engineering Construction Division, at (727) 892-5179.
