Watch Your Speed: It Can Save Lives and Save You Money

The officially posted speed limit in Venetian Isles is 25 mph. Unfortunately some residents and their visitors are not obeying these speed limits. Venetian Isles is a very family friendly community and very frequently kids of all ages play in front of their houses and in the streets. We all need to be on the look out for residents. Easing vehicle speed to posted limits can go a long way.

A pedestrian hit by a car traveling 40 mph has an 85% chance of being killed. At 30 mph, those odds decrease to 55%. By contrast, the chance of a pedestrian being killed if hit by a car moving at 20 mph is only 15%. A vehicle traveling 40 mph will still be going 36 mph when it hits a person who suddenly appears in the street 100 feet ahead of it; however, the average driver going 25 mph would be able to come to a full stop within 100 feet. (Killing Speed and Saving Lives, UKDOT, 1987)

To raise awareness for the Venetian Isles speed limit, the VIHA has teamed up with the Pinellas County Sheriff's Office on a two-part campaign. The first part of the campaign involves the posting of "Your Speed" traffic signs on Overlook then on Grand Canal to let drivers know how fast they are driving. The second part of the campaign involves stepped up patrolling and enforcement by the Sheriff's office in the coming weeks. The fine for a speeding infraction of 6 mph over the posted limit is \$80.50. That fine jumps to \$155.50 for speed infractions between 10 and 14 mph over the posted limit. It is a common occurrence for VI residents to cruise down grand canal at 35 mph.

Please hold your speed to the posted limits. You might save a life and you might also save yourself some money and hassle.

Neighborhood Crime Watch Report - Summer 2011

- A residential burglary occurred in early June on Carolina S. Thieves found the side garage door to be unlocked and they stole a valuable Trek LeMans bike. It was removed from it's stand. The thieves moved items away from the door in the garage in order to get out that side door. This incident happened late at night, and when the homeowner came out the next morning he could see his belongings had been moved around and that the door and yard gate had been left open, and the bike was gone. The owner believes this bike was targeted...an attempt to steal it out of his car previously was unsuccessful. The owners have changed out their side door to a much more secure entryway. Another security enhancement was installing a security bar on their main garage door.
- There was another residential burglary on Kansas N.in mid-August...the SPPD was notified, but no other details are available.
- One auto burglary was reported on Montana N. in early June. A theft of unknown description also happened on Mass. N. in early September.
- Other reports included a check on welfare on lowa S., a community hazard on Carolina N., and a DUI with property damage on Hawaii S.
- There were 15 burglar alarm incidences throughout Venetian Isles since June.
- There was one hit and run accident on Montana N. in late August.
- We had one grand theft report on Michigan N.
- There were 15 illegal fishing calls June through August on various streets along Grand Canal.
- We had one illegal parking problem on Mass. N. in late July.
- There were two open door and three "other alarm" calls on Hawaii S., Kansas S., and Carolina S.
- There was one simple domestic battery in early September on Carolina S., and two suspicious circumstances, one on Point Overlook and the other on Montana N. A suspicious person was seen and reported on Carolina N. in mid-June.
- Lastly, there was a report regarding trouble with an individual on Illinois S. in June.

Reminder: The VIHA Board is Revising Venetian Isles Deed Restrictions

This year we will make another attempt to propose some revisions to our Protective Covenants. There is a lot of work that goes into choosing, revising, and then the legal work to make sure that any changes are solid and enforceable. Work has been underway for many months now and we hope to bring three proposed revisions to a community vote later this year. It is hard to bring more than three to vote on because by their very nature, there are many explanations that accompany each proposed revision. This language can get confusing. Some key revisions currently under consideration are:

- ☑ Deed restriction #8 which would allow very specific types of metal roofs besides the current tile allowed today.
- ☑ Deed restriction #11 which would provide for more flexibility with placement of air conditioning equipment.
- ☑ Deed Restriction #22 which addresses fences and hedges, would increase the hedge height to 6 feet from 4 feet as residents want more privacy. Regarding fences, certain types of wrought iron and aluminum fences could be allowed along with the standard chain link fences allowed today. ■

Update: Support No Wake Zones in Venetian Isles

In our first Newsletter, of the year, we highlighted an issue raised by VI residents regarding the Grand Canal and Overlook bridges. The VIHA received a number of complaints about boaters causing large wakes as they flew through canals in the community.

This is definitely an unsafe situation that we are planning to address with "No Wake" signs and maritime enforcement.

In the previous article we asked you, the residents of Venetian Isles to let us know if you are in support of these measures. We are still seeking your input on the matter and want you to keep your responses coming.

Architectural Review Committee (ARC) Reminder

The Venetian Isles Architectural Review Committee (ARC) is comprised of six VI resident volunteers. The ARC is charged with reviewing plans for construction projects throughout Venetian Isles which includes any project outside the existing walls and roof of your house. Plans for any such project should be submitted to the ARC for approval BEFORE any construction is started. Please allow up to two weeks to review and comment on your plans. To avoid unnecessary delays and costs, not to mention potential Deed Restriction violations, no covered construction project should be started without written ARC approval. Some helpful tips often overlooked when submitting plans include providing a site drawing of the planned improvements which clearly lays out setbacks off of all property lines, remembering that all roofs must be concrete tile, 85% of first floor exterior walls must be of masonry construction and all air conditioning units must be positioned to the rear of the dwelling at grade level or on the roof (unless replacing a unit originally positioned on the side of the dwelling).
